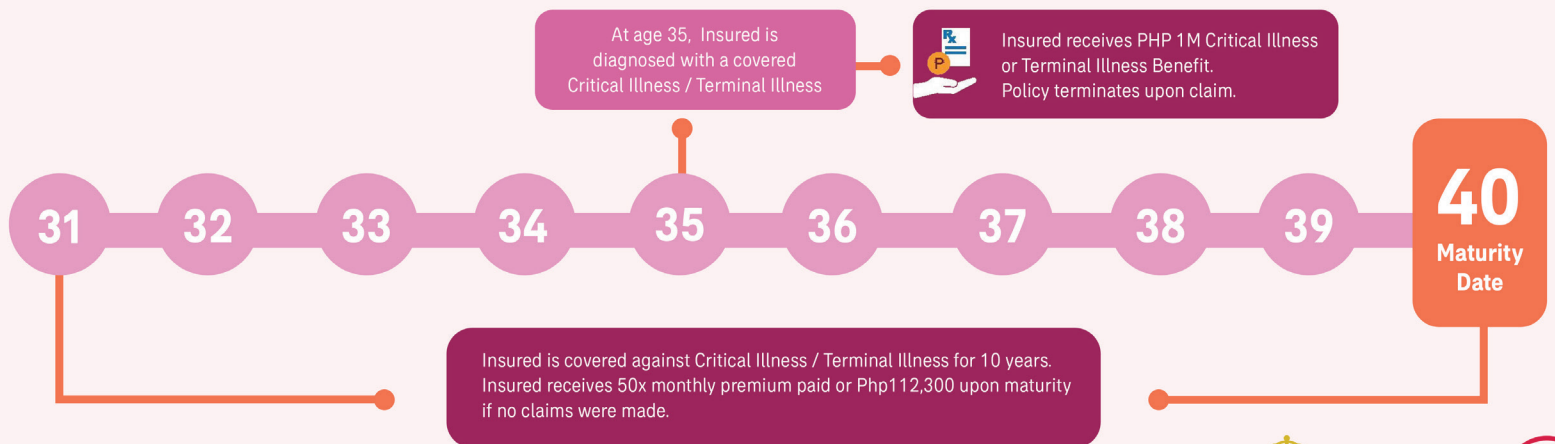
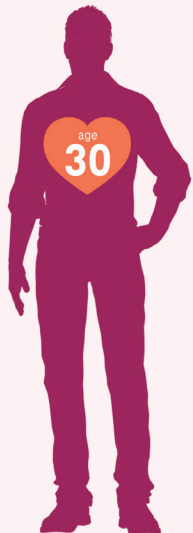
## Conditions on Critical Illness & Terminal Illness Benefits:

- The Critical Illness or Terminal Illness must manifest 180 days after Policy Effective Date to be eligible for a Critical Illness or Terminal Illness Claim.
- The Policy will be terminated upon payment of Critical Illness or Terminal Illness Benefit.
- Pre-existing conditions are not covered.

## Pre-Existing Condition Means

- Any illness or condition occurring before the Effective Date of your Policy or the approval date of the latest Reinstatement, if any, which satisfy the following conditions:
- any professional advice or treatment was given for such illness or condition;
  - such illness or condition was in any way evident to the Insured which would cause an ordinarily prudent person to seek diagnosis, care or treatment; or
  - the pathogenesis of such illness has started whether or not the Insured is aware of such illness or condition.
